The 26th AAHKS Annual Meeting submission period ended with a record number of 1,381 abstracts submitted—an increase of 11% from last year. The abstracts are undergoing a blinded review process, and those selected for presentation will be announced on the AAHKS website soon. The Program Committee will select 200 abstracts to be displayed as **Posters** and approximately 60 abstracts for **Paper** presentation. The Committee also selected eight outstanding **Symposia** and various **Surgical Technique Videos** that will add to the extraordinary educational experience. Symposia range from clinical to healthcare management topics—total hip and knee arthroplasty, revision surgery, pain management, international perspectives, infection, and health policy among others.

In addition, *Industry-supported Symposia* will fill out the schedule of options on Thursday and Friday before the start of the Scientific Sessions on Friday afternoon. The lineup of presentations covers topics from surgical technique to practice management to patient satisfaction.



Improving Value of Care with Ceramics

CeramTec

Technology in a new environment—Several factors determine the outcome of total hip arthroplasty and most of them are independent on each other, either antagonistic or synergistic. Important factors are short-term complications, readmission, long-term survivorship. Patient satisfaction, in terms of quality of life (QoL, QALYs), as well as economic factors have gained significant importance over the last years as the survivorship of most prosthesis systems has consistently increased.

One of the decisions to be taken is about the type of bearing for THA that best addresses the needs of the individual patient. This symposium will focus on the influence of the choice of bearings and its outcome for the major revision risks as well as economic aspects. Also in case of revisions, which are in the range of 10% of the primary procedures, and have generally a worse outcome, the decision for the bearing can influence the outcome.

Creating Value with Optimal Outcomes and Premier Patient Experience in Total Knee Arthroplasty

Value-based delivery and payment models are the topic of intense debate within the orthopaedic community and are fundamentally changing the practice of orthopaedic surgery. Bundled payments and other value-based methodologies have largely been focused thus far on primary joint replacement. In addition, patient outcomes and satisfaction are increasingly incorporated into the value-based payment models that affect hospital and surgical reimbursement and compensation.

This symposium will center on relevant discussion points surrounding total knee arthroplasty that drive value and create premier patient experience. Discussion topics include perioperative pain control, patient selection and risk factor optimization, controlling costs in the episode of care, choosing the optimal surgical and recovery setting and surgical techniques and implants to optimize patient function. At the conclusion of this symposium, the attendee should be able to identify ways to optimize the value of total knee arthroplasty through enhanced quality and cost-reduction methodologies.
