

#### • Goals:

- 1. Improve quality and value of care
- 2. Improve performance in CJR




	Baseline	Study Period
Readmission Rate	4.9%	3.9%
Medicare	4.9%	5.2%
Non-Medicare	4.9%	3.0%
Cost change from baseline		
Direct (hospital)		-27%
Cost to CMS (versus target)	4.8% (vs national average episode cost)	-11% (vs national target price)
